Landscaping

- · Mears have appointed Nurture Landscapes.

It was discussed that there is interest in mapping the KWH journey. This would include the pre-arrival, arrival and leaving processes.

There is also an interest in a 'Swap Room' of 'Drop shop' for KWH, potentially staffed by volunteers.

5. MATTERS ARISING

EV Charging Point

There was discussion about the cost of charging in M1/M2 basement car park and the suggestion Portal may want to consider more charging points at a better price point. GM noted basement charging issue needs to be dealt with as a standalone and that any Portal EV charging points should be sure of the intended public clients rather than replicating existing residential charging.

6. AOB

• Mobile Signal: There was discussion that many private properties on M1/M2 with metal cladding act as Faraday cages. Request was that Portal look into possibilities of boosting mobile signal in the M1/M2 area
